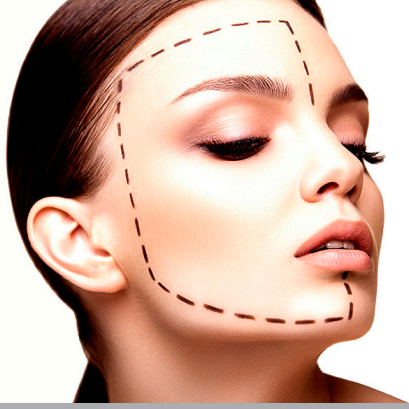

Subscription Details

 - c. A vinyl double-sided window/glass verified badge sticker
 - d. Full one-page online listing of your business, clinic or service at www.safetyinbeauty.com which will remain active for one year.
